2021 Amendment to the Constitution

Proposed for Action at the 2021 Special Convention of the Catholic Association of Foresters

Purpose of Amendment: The Constitution requires that we hold a convention between May 1 and June 30 each year, (and special conventions can also be held). However, Massachusetts General Laws, chapter 176, which regulates fraternal benefit societies domiciled in Massachusetts, is much less restrictive. Chapter 176, section 3(a)(1) state that the convention shall be held at least once every four years and does not have any mandate as to the time of year.

The Executive Board proposed this amendment at its August 9, 2021, monthly meeting to relax the requirement of holding the convention between May 1 and June 30 of each year. For instance, the Convention could be held in the fall at about half the price of a convention held between May 1 and June 30 at the same location.

The Committee on Constitution recommend a favorable action at its September 29, 2021, meeting.

Proposed Amendment:

Article X, section 1, which currently reads as follows:

Article X
Society Convention

Section 1. The Society shall hold a Convention between May 1 and June 30 of each year. The Executive Board shall select the date and place of the Convention and shall notify subordinate Courts of the date and place selected at least sixty days before the Convention.

Shall be amended to read as follows:

Section 1. The Society shall hold a Convention each year. The Executive Board shall select the date and place of the Convention and shall notify subordinate Courts of the date and place selected at least sixty days before the Convention begins.

The delegates to the 2021 Special Convention approved the above amendment.

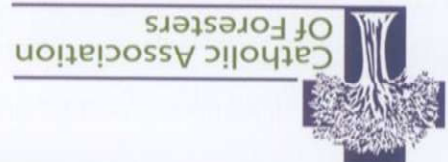
